Glacier's Edge Redevelopment Public Meeting 6:00 pm

A Public Information Meeting was held to discuss issues/opportunities for the Glacier's Edge Shopping Center and surrounding parcels. An introduction was provided by Schuenke and presentation provided by Tremlett. This meeting is part of a Dane County BUILD Grant to fund a planning effort to consider the viable design improvements and implementation strategies to ensure that Glacier's Edge shopping area remains viable into the future.

Following Public Information Meeting:

I. Call to Order

The meeting was called to order at 7:00 pm.

II. Discussion regarding the 2016 Streetscape Project Planning and Design by MSA Professional Services – Draft plans for Streetscaping Improvements were presented and discussed with MSA Staff. Input was provided in order to be incorporated into the final design. No action was taken for this item.

III. Discussion regarding a Public Art Program – Chuck Law and Kathleen Pape provided an introduction to the Public Art Program they have been working on and discussed opportunities with the Workgroup. No action was taken on this item.

IV. Update regarding the Wayfinding, Business Access, and Gateway Signage – Schuenke stated that all wayfinding, business access, and gateway signage will be complete by the end of the month. About half of the wayfinding signs have been installed to date.

- V. **Updated regarding streetscape fundraising** – Schuenke stated that approximately \$8,500 had been raised to date. Work will continue on this to raise funds to offset the cost of the improvements at least until Summer.
- VI. **Approval of Minutes – February 25, 2016** – A motion was made by Devitt, seconded by Hansen, and unanimously carried by the Streetscape Workgroup to approve the minutes from the February 25, 2016 meeting.
- VII. **Set next meeting date** – The next meeting will be held Thursday, June 30th at 7:00 pm.
- VIII. **Adjournment** – The meeting was adjourned at 8:30 pm.
