## CHAPTER 14

**SECTION 14.01 General Provisions.** The basic deposit amounts for violations of the Code are as shown on this schedule. The total deposit amounts for such violations are the basic deposit amounts plus any costs, fees, assessments, charges, surcharges, and penalties as imposed by law. The general deposit provision at the end of this schedule applies to any offense that is not specifically described in this schedule and is not stated in a state schedule. The forfeiture range for each offense is shown in parentheses. The forfeiture ranges are included for convenience and are not part of the approved deposit schedule. The forfeiture ranges may change and may not be as shown on this schedule.
